**Online participation:** Each participant will receive a secured link on the day of the conference. This link will enable participants to access a private space on the Youtube platform. Participants are requested to check, with the link they will have received, if they have access to the Youtube platform before the start of the seminar. The number of participants to the webinar online Youtube version is unlimited.

**On premises participation:** The number of seats available for at PwC premises is limited to 50 and will be attributed on a “first come, first served” principle.
